

ORDINANCE NO. 1556 N.S.

AN ORDINANCE CHANGING SOLID WASTE RATES IN THE CITY OF COLVILLE AND REPEALING ORDINANCE NO. 1537 N.S.

The Council of the City of Colville, Washington does hereby ordain as follows:

SECTION 1

The City Council hereby adopts a schedule of monthly charges and rates for solid waste collection for residential, commercial, and industrial accounts as follows:

(The rates do not include State Refuse Taxes, City Utility Taxes or City Administrative Fees.)

SECTION 4


This Ordinance shall take effect April 1, 2016, after its passage, approval and publication.


